1. General Government & Executive Power

Resources for understanding the balance of power, the executive branch, and how legal precedent is set.

U.S. Courts — About the Federal Courts	Official resource explaining how federal courts work, how cases reach SCOTUS, and how judicial precedent is established.
Oyez — Supreme Court Cases	User-friendly database of Supreme Court cases with oral argument audio and plain-language summaries.
Brennan Center for Justice	Nonpartisan law and policy institute tracking presidential power, voting rights, and democracy issues with research reports.

Congress.gov	Official source for tracking federal legislation, floor votes, committee hearings, and Congressional records.
GovTrack	Independent tracker of bills, votes, and Congressional activity with data-driven analysis.

Resources for understanding how federal dollars are allocated and tracking government expenditures.

USASpending.gov	Official federal database showing where government money goes — contracts, grants, loans, and direct payments by agency and state.
Congressional Budget Office (CBO)	Nonpartisan analysis of federal budget and economic outlook; publishes reports on spending, deficits, and policy costs.
Peter G. Peterson Foundation	Budget and fiscal policy analysis with charts and explainers on federal spending trends.

3. Immigration

Addressing constitutional rights and community resources in Hawai'i.

Hawaii Appleseed — Housing	Reports and advocacy on housing affordability and homelessness in Hawai'i.
National Housing Law Project	National resource on tenant rights, affordable housing preservation, and housing policy.
Urban Land Institute — Hawaii	Real estate and land-use research, including reports on Hawaii housing supply and affordability.

5. Education — DOE, Native Hawaiian Students & Federal Policy

Native Hawaiian Education Council	Federally recognized body coordinating Native Hawaiian education programs under the Native Hawaiian Education Act.
Title VII — Native Hawaiian Education Act	U.S. Department of Education page on the federal program funding Native Hawaiian education initiatives.

U.S. Department of Education	Federal policies, funding streams, and civil rights resources. Track changes to Title IX, Title VI, and grant programs.
Education Trust	Nonpartisan research on educational equity, with analysis of federal and state policy impacts on underserved students.

6. Homelessness in Hawai'i

Resources for understanding and addressing homelessness, particularly as it relates to interstate migration.

Kaua'i Economic Opportunity (KEO)	Local community action agency providing emergency shelter, housing assistance, and social services on Kaua'i.
National Alliance to End Homelessness	National research, policy analysis, and data on homelessness causes, demographics, and effective interventions.
HUD Exchange — Homelessness Data	Federal data on homelessness by geography, funding, and program type.

7. Environmental Issues — Ocean Safety, Tourism & Invasive Species

Resources on environmental education for tourists, ocean safety, and invasive species management in Hawai'i.

Hawaii Legislative Reference Bureau	Provides research and bill drafting for the Legislature; publishes plain-language guides to state law.
State of Hawai'i Judiciary	Court records, self-help legal resources, and information on how to file complaints or access justice.
Legal Help & Accountability	
Legal Aid Society of Hawai'i	Free legal services for qualifying residents; can advise on government accountability and civil rights.
Office of the Ombudsman — Hawai'i	State office that investigates complaints against state and county agencies and recommends remedies.

State Ethics Commission	Enforces public officials' code of conduct, financial disclosures, and conflict-of-interest rules.

11. Student Civic Engagement — Joining Federal Conversations

<u>University of Hawai'i Board of Regents</u>	UH students can testify at BOR meetings and submit formal requests on policy matters affecting the UH system.
<u>UH Student Caucus</u>	System-wide student association that sends student delegates to the state legislature and advocates on higher education policy.
<u>American Student Government Association</u>	National organization supporting student government leaders with resources, conferences, and leadership training.

B. Federal Internships & Fellowships for Students

<u>Mānoa Political Internship Program</u>	These internships offer a rare opportunity to work at the top levels of government.
<u>Sen. Mazie Hirono — Internships</u>	Offers internships in Washington D.C. and Hawai'i district offices; open to college students.
<u>Sen. Brian Schatz - Internships</u>	Offers internships in Washington D.C. and Hawai'i district offices; open to college students.
<u>Rep. Ed Case — Internships</u>	Congressional internship opportunities for Hawai'i students in D.C. and Honolulu offices.
<u>Rep. Jill Tokuda – Internships</u>	Congressional internship opportunities for Hawai'i students in D.C. and Honolulu offices.
<u>USAJOBS — Student Programs</u>	Official federal job portal with student and recent graduate programs (Pathways Internships, PMF Program).
<u>Truman Scholarship Foundation</u>	Prestigious scholarship for college juniors committed to public service careers, including policy, government, and advocacy.

C. Youth Civic Leadership Programs

<u>Senate Youth Program (USSYP)</u>	Selects two high school seniors from each state to participate in a week-long Washington D.C. program with Senators, Cabinet members, and Supreme Court Justices.
<u>Close Up Washington</u>	Experiential civic education program in D.C. bringing students face-to-face with policymakers; college programs available.
<u>Boys & Girls Nation</u>	National leadership program culminating in visits to Congress and the White House.

D. Advocacy Networks & Coalitions

<u>Generation Citizen</u>	Action civics organization helping students identify community problems and advocate for policy solutions with real government officials.

<u>Student PIRGs (State PIRGs)</u>	Student-led public interest advocacy groups on campuses; run campaigns on climate, voting rights, and government accountability.
<u>Campus Vote Project</u>	Helps college students register, vote, and engage with elections and elected officials.
<u>Young Invincibles</u>	Advocates for the economic interests of millennials and Gen Z; engages young adults in federal budget and health policy.
<u>The Congressional App Challenge</u>	Annual competition for students to create apps addressing policy problems; winners present at the U.S. Capitol.
<u>The Fund for American Studies (TFAS)</u>	Runs summer institute programs in Washington D.C. for college students focused on government, economics, and journalism, with direct access to policymakers. Rooted in free-market and limited-government values; well-regarded across the political spectrum.

E. Hawai'i-Specific Civic Pathways

<u>PACE — Hawaii Commission to Promote and Advance Civic Education</u>	The Hawaii Judiciary's civic education commission; advocates for civic learning programs statewide.
<u>Project Citizen — Hawaii</u>	Students research a public policy problem and present a portfolio to real government officials; leads to State Showcase and national competition.
<u>We the People — Hawaii</u>	Simulated congressional hearing program where students argue constitutional principles before volunteer judges, often attorneys and judges.
<u>Hawai'i State Aha Moku</u>	State body incorporating traditional Hawaiian resource management; engages Native Hawaiian students in environmental governance.
<u>Office of Hawaiian Affairs — Youth</u>	Grants and programs for Native Hawaiian youth leadership and civic participation.

<u>Find Your Federal Representatives</u>	Enter your zip code to find your U.S. Senators and House Representatives with direct contact links.
<u>Sen. Mazie Hirono</u>	Contact form for constituent services, policy questions, and scheduling meetings with staff.
<u>Sen. Brian Schatz</u>	Contact form for constituent concerns; Senator Schatz is active on technology, climate, and Native Hawaiian issues.
<u>Rep. Ed Case (HI-01)</u>	Contact form for Oahu's 1st Congressional District representative.
<u>Rep. Jill Tokuda (HI-02)</u>	Contact form for the 2nd Congressional District, which includes Kaua'i.

<u>OpenSecrets</u>	Tracks campaign contributions and lobbying spending; helps students understand who funds political decisions.
<u>Ballotpedia</u>	Encyclopedia of U.S. elections, ballot measures, government officials, and civic information.

iCivics	Free, standards-aligned civics games and lesson plans for all ages from Justice Sandra Day O'Connor's organization.
Center for Civic Education	Publisher of We the People and Project Citizen curricula; resources on constitutional principles and civic participation.
Annenberg Classroom	Free First Amendment and constitutional law resources including documentary films and lesson plans.
National Constitution Center	Interactive tools, podcasts, and resources explaining the U.S. Constitution and its ongoing interpretation.
Civic Nation	Coalition of organizations promoting voter registration, civic education, and inclusive democracy.
Hawai'i Council for the Humanities	Supports public programs exploring Hawai'i history, culture, and civic life with grants and community events.
